Fish & Lake: If you haven't seen it yet, keep an eye in your mail box. Fish & Lake's Lake Life Ledger is delivered once a month to your Cinnamon Lake mailbox. It's a good source of information on what is being done to keep the lake healthy. Past issues talked about algae blooms, fertilizer guidelines and surfactants. This year's Carp Derby is underway and runs through Labor Day. Prizes for the largest fish, most fish, most weight, and Junior Anglers will be given out. The objective is to remove muck-stirrers out of the lake because they contribute to algae and water clarity problems and destroy the nests of the other fish species.

Heads up: A newer trash compactor is on the horizon for Cinnamon Lake. The old one will be removed and some work will be required to put the replacement compactor in. No date has been set yet for when the work will begin.

Events Committee: Water Aerobics is scheduled for Sundays on August 4, 8, 11, 15, 18 and 25, 5-6 pm and Thursdays 6-7 pm at the pool. Chair Yoga is at the Lodge from 6:15 to 6:50 pm on August 5, 19 and 26. Euchre is at the Lodge on August 23 from 7 to 9 pm. Card Board Boat Races are set for August 31 from 10 am to 2 pm at the Beach. If you haven't started building your boat, now is a great time to get started. Fish & Lake will be holding a pancake breakfast from 9 to 11 am at the Lodge before the boat races. Come with a big appetite. Events is also helping with the Pool Hawaiian Luau Party, set for August 11 at the Pool from 6 to 9 pm. Come and have fun. (Normal Pool fees apply.) The Events Committee's next meeting is August 7 in the Community Center at 6 pm.
